EXPLANATORY NOTES

1. This Self-Exclusion Request Form can be used by both existing betting account holders and non-account holders who are applying for self-exclusion from Telebet Account Services. For an existing betting account holder seeking self-exclusion, please fill in Section (A). For non-account holders, please complete Section (B).

An applicant for self-exclusion, account and non-account holder alike is to complete the relevant Section and submit the completed form **in person** at **178 Clemenceau Avenue #01-00 Haw Par Glass Tower Singapore 239926**. Please bring along your identification documents for verification purposes. Singapore Turf Club will not process any application by post or through the telephone.
3. Singapore Turf Club however shall not be liable under any circumstances for any loss or compensation of any kind if the applicant continues; or for whatever reason is still able to continue with betting through a betting account after the self-exclusion.
